(cont'd) Staff Development/Federal Relations News:

Reimbursement for miles traveled will be actual map miles from point A to point B and back. Standard map miles should always be used when available.

The Accounts Payable Office will utilize MapQuest® (http://www.mapquest.com) to determine reimbursable mileage for all out-of-state travel. For in-state travel, the Accounts Payable Office mileage chart found at https://www.uwyo.edu/ACCOUNTSPAYABLE/ will be utilized. Mileage will be calculated from the origin city to the destination city. Personal travel mileage such as to entertainment venues, movies, shopping, etc. is not reimbursable.

There is a provision in the UniRegs that allows for indirect route mileage (travel to clientele locations, meetings, etc.). It just has to be submitted differently. If someone does make a side trip or something it will need to be indicated in the itinerary/business purpose area.

What you need to do is enter the mileage for the trip to town (example Casper), then the traveler will keep odometer readings to their destination after arriving in Casper and submit a note with the readings to say what her destination/business purpose was and that it was to a rural destination outside the city limits. See the UniReg below:

<u>UniReg 11.j.</u> - For indirect route mileage, odometer readings must be taken at the beginning and end of each side trip and the mileage for the difference in odometer readings, rounded to the nearest whole mile, should be claimed. The odometer readings for indirect route mileage must be recorded separately on the mileage affidavit portion of the travel expense voucher and must be clearly identified with an explanation as to reasons why the side trip(s) were necessary business expenses.

Civil Rights Tip

I noticed reading 2010 reports that only a few 4-H educators mentioned conducting a 4-H Expansion and Review meeting. Expansion and Review committees are required for Civil Rights compliance. The purpose of the committee is to gather input on ways to expand youth audiences; by gender, race or ethnic origin, geographic locations in a county, or any underserved audience. The committee should meet at least once a year, and be comprised of individuals outside of the traditional 4-H program. For example, a representative from the school district, DARE officer from police or sheriff office, other youth groups, community leaders and perhaps one 4-H leader. Minutes should be taken as a record of the meeting. When reporting, this committee meeting would be listed under assessment of needs. Contact Susan for more information.

Converse County 4-H Educator, Position #4365. This position is based in Douglas; this is a full time University Extension Educator, non-extended term track position. A bachelor's degree is required. Upon completion of master's degree, demonstrated excellent performance, and availability of funds, promotion to extended term track extension educator is possible. Screening is currently underway. Interviews will be held in early May.
