# Administrative News from Glen:

I am delighted to report that actions associated with Academic Plan 2009 – 2014 are just about completed. Implementation of the recommendations of the four academic planning working groups (County Coordinator Review, Mentoring, Stakeholder Input and Branding and Marketing) is in process. I will briefly discuss the final outcomes and implementation of each.

**County Coordinator Review** – The review process as recommended will be implemented (<u>https://uwadmnweb.uwyo.edu/</u> <u>employee\_resources/county-coordinator.asp</u>). The position of county coordinator is an important leadership position in UW Extension. All educators should be trained and prepared to serve. Conceptually, every eligible employee should have an opportunity to serve. It will be the responsibility of the incumbent county coordinator to train and prepare each eligible employee for the assignment.

The county coordinator assignment will be reviewed every five years. Associate Directors will manage the review process. The review will be composed of an application for the assignment. Each eligible employee will be encouraged to apply. The administrative team will consider the applications and make a decision on the county coordinator assignment. One county from each Extension Area will be reviewed each year. The longest serving county coordinators will be reviewed first.

**Mentoring** - The Mentoring Working Group recommendations will be implemented as proposed (<u>https://uwadmnweb.uwyo.edu/</u> <u>employee\_resources/Mentoring.asp</u>). Susan James will serve as the coordinator for the mentoring program as a part of her staff development responsibilities; will organize mentoring training; and, will work with the associate directors to see the program is implemented for each employee.

**Stakeholder Input** – The Stakeholder Input Working Group recommendations will be implemented as proposed (<u>https://uwadmnweb.uwyo.edu/employee\_resources/</u>

<u>StakeholderInputReportWithChanges6-1-11.docx</u>). Susan James will coordinate stakeholder input collection as a part of her federal relations responsibility; will organize training for employees (EPIC this year contains training in facilitating groups to collect input); and, will work with associate directors to see that input is being collected in all areas of the state and in all initiatives.

**Branding and Marketing** - The Branding and Marketing Working Group recommendations will be implemented as proposed (<u>https://uwadmnweb.uwyo.edu/employee\_resources/</u> <u>MarketingReportWithChanges6-9-11.docx</u>).

# **Civil Rights Tip**

What are the protected classes covered under civil rights? There are six protected classes under the Civil Rights Act of 1964. Age, gender, race, ethnicity, handicap, and religion are protected classes. What does being a protected class mean? That in employment and programs we do not discriminate – for instance we have no minimum or maximum age for employment (other than degree requirements). It is inappropriate to imply that someone is at an age to retire, or that only males should hold certain jobs. This might be a good discussion topic for a staff meeting.

Be sure to give credit if someone else developed the program – state that you adapted, or presented a power point presentation developed by \_\_\_\_\_\_. When using materials developed by someone else, whether it is a handout or power point for a presentation, always credit the original author through a slide that states their name and title at the beginning or end. Same is true with publications.

Remember that great extension work is all about building relationships with our clients, partnering agencies, organizations, and colleagues.
