Civil rights legislation simply states that there will be no discrimination in program delivery or in employment based on race, national origin, sex, age, religion, or handicap.

Reporting Tip

Second Reminder: Last fall we announced that we were moving to a new on-line reporting system. The system has been up and running since November. We no longer require UW Extension employees to report time. The new system is used to gather contact data only. If you have no contacts – you don't report any data for that day. The new program is web based, and can be accessed from your PC, laptop, I-pad or other tablet, and smartphone. As in the past, this data will be collected from October 1, 2013 – September 30, 2014. The eXtension Moment

“You have a new Ask an Expert question”

As you peruse your email inbox, don't be too quick grumble (\$%#@) and then delete “*You have a new Ask an Expert question (#20...)*.” This email subject means that a Wyoming resident has personally reached out to UWE seeking our research-based knowledge. It is really the same as a phone call or an office visit and shouldn't be ignored! Even if you do not have time to answer the question right away, click on “Assign to me, indicate I'm working on it” to be sure that the question wranglers don't think you are ignoring it. If you do not have the expertise to answer the question, simply “reassign” it to a colleague or the “Question Wrangler” (see the images below). This will ensure that folks, many who are contacting Extension for the first time, get a prompt response, hopefully within one business day.
