**Civil Rights Tips – Grassroots Organizations:** 

Can employees in your office identify grassroots organizations in your county? Grassroots organizations are local groups that could be in a position to help us target or reach some underserved audiences. Grassroots organizations will vary from county to county, because they are locally based. For example in agriculture, groups like Farm Bureau. Stock Growers, Wool Growers, Wheat Growers and other commodity groups could be considered a grassroots organization. Even though they may have state and national ties, they form a local organization. Why is it important to identify grassroots organizations? If a new educator is hired, not familiar with clientele and want to target or promote educational activities in a county, knowing where to find groups of potential clientele is important. If you are new to a county or area and don't know what grassroots organizations exist, a good place to start is the local chamber of commerce because they may have a list of organizations and contact information.
