Civil Rights Tip

County civil rights training reviews are being conducted this fall. Many thanks to staff members in Washakie and Laramie counties who have had their reviews. Platte, Sheridan, Goshen, Lincoln, and Uinta counties will have reviews in October and November. The purpose of county reviews is to provide training and raise awareness of the documentation required at the federal level to document that Extension programs are open to everyone. There is a four year rotation, so each county and the Wind River Reservation office are visited every four years.

Customer Service Tip

Over time, organizations gradually develop their own special terminology, abbreviations, acronyms, and jargon. Extension and our national system are famous for acronyms. For those in the know, these special words are effective in getting across long phrases. But for newer employees both educators and support staff, and people from outside the organization – like customers – this language can be bewildering.

At new employee training each year a list of common acronyms is shared. Make sure a copy is available in your office to use as a translation tool. Be sure to spell out acronyms and abbreviations the first time they are used in a document. For example "The NIFA (National Institute of Food and Agriculture) is our national partner". When working with clientele, keep in mind they won't know the Extension jargon. Communicating clearly is a first step in good customer service, both internally and externally.
