#### 4-H Educator's Letter...

The time is drawing closer for this year's Lincoln County Fair. A few reminders as fair season approaches: · All 4-H members need to enroll in the 4-H project on ZSuite and then enter projects at https://www.lincolncountyfair.info/ for the county fair. Enrolling in the project on ZSuite does not automatically enter your project for the fair. These are two separate systems!!

- The deadline for entries on the fair's website is July 30 before midnight. If you enter projects late, you will have to pay a \$100 late fee, so be sure to get your entries in on time.
- Check with the Afton and Kemmerer Lincoln County Extension Office for fast passes for your animals. They will be available mid-July.
- Livestock members forms you need for your animal to be allowed to weigh-in:
  - ♦ 4-H/FFA Responsibilities form
  - ♦ Consignment form
  - ◆ Brand Inspection the original copy (unless you gave it to Jill, Shar, or Deborah already)
  - Current (within 30 days of fair) written health inspection
  - ♦ Proof of fair entry
- Keep up on your record books in July and August so you are ready to turn it in after fair!

With that, good luck completing projects, and do not hesitate to contact Afton (885-3132) or Kemmerer (828-4092) offices for any assistance you need with projects, fair entries, etc.

#### 2025 Fair Changes/ Reminders

Date-August 1-9, 2025

Theme — "Fun Everywhere for Everyone"

Fair Entry Deadline—July 30, 2025

Animal Open Classes—Class fee is \$5/per animal.

YQCA Certificate—All YQCA participants are responsible to print, laminate, and hang their certificate at fair.

Premiums—will only be available Wednesday-Saturday (11 am to 6 pm) of fair at the payout window by the fair

4-H Horse Certification Testing Deadline—must be done before July 20 of the fair year.

Improper Conduct—An exhibitor and/or parents may be asked to leave the fairgrounds for improper conduct.

Fitting—There will be absolutely no altering market animals' natural physical build by means such as tubing, drenching, airing, injections, or insertion of foreign material under the skin. If an animal is deemed in need of medical intervention by tubing, it is the responsibility of the exhibitor to notify the livestock coordinator and arrange for their personal veterinarian to come to the fairgrounds, observe the animal, prescribe treatment, and treat the animal. There will be not tubing or drenching allowed for cosmetic purposes. All concerns for animals health must be brought before the Livestock Coordinator before action is taken.

Barn Safety—ALL BARN AISLES MUST BE KEPT CLEAR, no blocking of the aisles is allowed. Grooming, cleaning, storing of equipment, etc. that blocks the passage will not be allowed. This is a safety issue and will not be tolerated.

Auction Resale—There will be no resale allowed for any market animals, the sale animal has become the property of the buyer upon the final bid being made. If the owner wishes to sell their newly acquired animal, it is up to the new owner to facilitate that sale. It will no longer be allowed to resell during the livestock auction.

Fast Pass—The Fast Pass will be available starting July 17 at the Extension Offices. Avoid waiting in line! Required market livestock forms: Signed 4-H/FFA Responsibilities form, Current Health Certificate (within 30 days), Brand Inspection (Beef, Sheep) or Bill of Sale (Swine & Goats), Signed Consignment Form (at Ext. Office), Receipt showing entry into the Lincoln Co. Fair. You must have proof that you completed the forms at weigh-in.

Market Livestock Forms Table will be on Tuesday afternoon from 1-4 pm. Parent & exhibitor must be present at the forms table. Requirements for weigh-in: Health Certificate, Brand Inspection/Bill of Sale, Proof of entry into the Lincoln Co. Fair, 4-H/ FFA Market Livestock Responsibilities Form, Sale Consignment Form, and forms table receipt.

Premium Payouts Will Begin on Wednesday of Fair. The windows by the Fair Board Office are open 11 am to 6 pm. NO Premiums will be paid after fair.

#### Reminder—Parking During Fair Week

During the week of fair, no livestock trailers will be allowed to be parked and left in any of the barn areas (especially north of the beef wash area and north of the sheep barn). These are for loading and unloading only. There is plenty of room on the west end of the fairgrounds to leave the trailers. This will cut down on congestion around the barns and create more parking for personal vehicles.

#### Reminder—Horse Stalls

If you need a horse stall during fair, you must reserve it. Paying online does not reserve your stall. Indoor stalls are limited. To reserve a stall, you must call Josh Nield, 307-248-0475.



- 1. To enter in the 4-H/FFA Departments you must be a registered member those programs. Entries in all open divisions are not limited to residents of Lincoln County.
- 2. There is a copy of the fair book on the website under Get Involved.
- 3. Residents must complete online entry; this is the ONLY method. Exhibitors must complete all steps including the last step, **printing your entry tag (4-H Generals Only).**
- 4. Print your Fair Receipt.

#### **PREMIUMS**

Premium cash will only be distributed during the fair Wednesday-Saturday 11 am to 6:00 pm at the payout window by the fair board office. No premiums paid after fair. Premiums not picked up will be forfeited. No checks will be mailed.

#### 2025 Responsibilities of 4-H/FFA Market Livestock Members

Large Livestock & Small Animal Entries must be made prior to Midnight, WEDNESDAY, July 30 for online entries. Entries (Livestock only) received after the deadline will be assessed \$100 per family late fee to enter into fair. Contact the Show Coordinator or one of the two Livestock Fair Board members to pay late fee. (Must show some entry in ShoWorks to waive fee). Online entry link: <a href="http://lincolncountyfair.info">http://lincolncountyfair.info</a>. Click on Online Entries Tab. (See the Livestock Online Entry Procedure section for instructions). Do Not print tags for animal entries.

**Rules/Regulations** – All Exhibitors are cautioned to carefully READ the rules and regulations as well as each division rules, they will be strictly enforced!

Improper Conduct - An exhibitor and/or parents may be asked to leave the fairgrounds for improper conduct.

**Forms Needed before Weigh-In is Allowed** – 4-H and FFA members <u>must complete</u> the following forms and turn in the forms to the forms table before weigh-in to be eligible to sell their animals at the auction.

42H/FFA Responsibilities form and have it signed and dated by parent/guardian and member. (Form also found online at lincolncountyfair.info).

#### Consignment form

<u>Brand inspection (Form A) or bill of sale</u>. For Beef & Sheep Project members -You will need to meet with the brand inspector, show your papers to him and sign his sheet as owner of the animal. Swine & Goat Project members will need to show their bill of sale at the forms table.

<u>Current (within 30 days) written health inspection</u>, market beef heifers must be verified open by a certified vet, (PLEASE HAVE THIS COMPLETED BEFORE ARRIVING ON THE FAIRGROUNDS AND MUST BE SIGNED BY A VET) required in hand. No animal will be allowed to exhibit or compete without a current Certificate of Veterinary Inspection, or meeting species requirements as outlined. The professional judgment of the veterinarian will be the final deciding factor on all animals.

<u>Proof of Entry</u> – You will need to provide proof that you entered online into the Lincoln County Fair.

**Time for Forms Table** – someone will be at the forms table Tuesday afternoon at 1-4 pm. A receipt from the forms table will be required to weigh-in animal. **Both Parent & Participant must be at the table**.

Animals in Place & Weigh in/Check in: All large livestock are to be in assigned stalls by 3 pm on Tuesday of Fair. If not in place, animals stay in trailers and weigh in last. A current (within 30 days) written health inspection (PLEASE HAVE THIS COMPLETED BEFORE ARRIVING ON THE FAIRGROUNDS AND MUST BE SIGNED BY A VET) and is required in hand. Health Certificate, Brand Inspection, proof of entry into the Lincoln Co. Fair, and forms table receipt are required before you are allowed to weigh-in animal. Weigh-in for your animal at the fairgrounds is Tuesday of Fair — Swine (4 pm in Pig Barn), Beef (4 pm at scales) & Sheep/Goat (4 pm at Sheep Barn). Scales will be open for 30 minutes after last animal has weighed in. Rabbits/Poultry — need to be checked-in Monday from 4:30-6:30 pm. Dairy Goats — need to be vet checked on Wednesday at 2:30 pm.

**Shows/Sale Dress Code** — white shirt (long or short sleeve) and dark jeans for 4-H members, appropriate uniform for FFA members, and appropriate footwear (no open-toed shoes or sandals at any time). **4-H members are required to wear white shirts for all contests & shows. If you show up without a white shirt, you will be given a participation ribbon.** 

**Showmanship** - Sign up for classes by deadline above. No entries will be allowed the day of the show.

**Stall Fee** - There will be a \$20 per animal (one-time) large livestock fee. This is the class fee associated with the market class. It will automatically be assessed during entry. The fee needs to be paid online by the deadline stated above.

**Stall Cleaning** - If the (livestock/horse) stall is not cleaned after fair and the sale, exhibitor/sale participant will not be assigned a stall for the next year's fair. ALL BARN AISLES MUST BE KEPT CLEAR, no blocking of the aisles is allowed. Grooming, cleaning, storing of equipment, etc. that blocks the passage will not be allowed. This is a safety issue and will not be tolerated.

**Market Animal Quality** – Animals deemed by the judge as not properly conditioned will receive a <u>white</u> ribbon and will not be eligible for the sale.

**Back Tags** – A back tag number will be assigned to each livestock exhibitor to be used through all livestock events that the exhibitor has entered (except the sale). The back tag number must be returned to the table after their last show.

**County Tail Docking Rule** - "No extreme docked lamb will be tagged for the Lincoln County Fair. Lambs that have been redocked after they have been tagged will be disqualified. Any qualifying fair exhibitor who wants to go to State Fair will have to follow the State Fair Tail Docking Rule."

#### <u>Resale</u>

**Lambs** – Any lambs that won't be accepted by the resale buyer because of short tails will be returned to the sale participant at the expense of the sale participant. The sale participant will have the market price deducted from his/her sale check.

**Resale Buy Back** – The sale participant/owner of the animal can purchase only their animal back from the resale contractor. The sale participant will have to make all the arrangements with the resale contractor.

**Resale Animals** – Resale animals can leave the fairgrounds only when the "resale" trailer leaves. All other large and small animals (includes poultry and rabbits) cannot leave the grounds until 5 pm.

**During the Sale each animal sold only once** — Each market animal may only be sold once at the sale unless pre-sale arrangements have been approved by the livestock committee.

**Premium Eligibility** - To be eligible to receive a premium, animals must be displayed on the fairgrounds for the week of fair. The exception would be dogs, cats, pocket pets, horses, and breeding livestock. All buckles, awards, and premiums must be claimed within the same fair year as they were won. Premiums will only be available Wednesday-Saturday (11 am to 6 pm) of fair at the payout window by the fair board office.

**Show/Sale Decisions** - The fair committee for each livestock division will be the Fair Board Chairperson, the Fair Board livestock members, FFA Advisor, Extension Educator, and the Livestock Show Coordinator.

**Sale**— Each exhibitor will be allowed to sell only <u>one</u> animal of any species. Check sale order; be ready when it's your turn. Animals that sell at the livestock sale will be assessed a <u>2% commission fee of the sale price</u>.

**Sale Animal** – If by the last market show, the Livestock Committee has not been informed of which animal you want sold; the committee will pick your highest placing animal and that animal will sell in the sale. Remember that Grand and Reserve Champion animals must sell at the sale.

#### Herdsmanship/Stall Information

- a. Stalls will be assigned, and the stall cards will be in place by 2 pm on the Thursday before the fair. A (within 30 days) written health inspection (signed by a vet) is required in hand, if animals are brought to the fairgrounds before 3 pm on Tuesday of the fair. There will be NO modifications of pens/stalls.
- b. Breeding Sheep & Goats may be brought the day of the show & taken home after, if there are no stalls available. The breeding animals must still have a vet check (See Schedule of Judging for day & time).
- c. The large animal Herdsmanship Award will be based on a score sheet so clubs can improve from year to year. The award's objectives are to create pride in the barn area and promote healthy competition between clubs. The large animal Herdsmanship winners will receive recognition at the rodeo; a banner to display in the barn for the next year, and a traveling trophy to be awarded at Awards Night and be able to pick their stalls for the next county fair.
- d. <u>Exhibitors alone</u> are responsible for the cleanliness of the stalls and pens. <u>4-H/FFA members must provide their</u> own hoses.
- e. Alleyways must be kept free of trash and manure.

**Red Stall Tag** - Alleyways must be kept free of trash and manure. Exhibitors are responsible for the cleanliness of the stalls and pens. If the superintendent or livestock coordinator tags an unclean pen and it is not cleaned within eight (8) hours, the exhibitor may be asked to take the animal home and will not be eligible for the sale. Stalls <u>must</u> be kept clean during the fair and <u>must be completely cleaned</u> after the sale when your animals leave the fairgrounds.

**Fitting** - A 42H or FFA member is expected to fit his own animal at fair. However, in the interest of safety, a 42H or FFA member may be assisted by others (i.e., member, parent, or another adult). Assistance is defined as a learning situation where the teacher (helper) is teaching the 42H or FFA member a technique in fitting or showing. The teacher2adult is allowed only to show how; the member is expected to perform the majority of each technique and/or skill required. There will be absolutely no altering market animals' natural physical build by means such as tubing, drenching, airing, injections, or insertion of foreign material under the skin. If an animal is deemed in need of medical intervention by tubing, it is the responsibility of the exhibitor to notify the livestock committee and arrange for their personal veterinarian to come to the fairgrounds, observe the animal, prescribe treatment, and treat the animal. There will be not tubing or drenching allowed for cosmetic purposes. All concerns for animals health must be brought before a member of the Livestock Committee before action is taken.

**Shows** - check show schedule and be on time for your class. Please follow directions of show superintendent. Any animal can be shown ONLY IN ONE (1) CLASS (either market or breeding – NOT both).

**Picture** – The Fair Board will not be taking pictures of the kids! A card stock "thank you" form can be picked up from the Fair Board Office or payout window. A picture backdrop will be provided.

**Thank you letters** - send letters to ALL your buyers (mandatory). Mail them and let Jill Hubbard, the Extension Secretary, know you have mailed the buyer thank you. We <u>strongly encourage</u> that you also send a "thank you" to the addon buyers. You can get a list of your buyers and add-ons from the Extension Office a few weeks after the fair.

**Processing Information Sheet** – The buyer will choose how to process their meat: either by having a wait period or letting the animal get on the processing trailer. **Pick up a copy of your (green) processing information sheet before you leave the sale**. It has the name and phone number of your buyer and processor information. It is **your responsibility to contact your buyer** and make sure the buyer's instructions are followed to process your animal. Please call the Extension Office if your processor information changes.

(4-H Record Book Deadline) - Record books are to be downloaded, printed out, and given to your leader or the Extension Office by Monday, Sept. 8, 2025.

(FFA Record Book Deadline) – The record book is due one week after state fair to the FFA Advisor.

**Checks** – Livestock sale checks are usually release at 4-H Awards Night after October 1. Livestock sale checks must be cashed before 60 days after the check issue date. If not, the participant must attend a fair board meeting to ask for the check to be re-issued. A re-issue fee of \$50 will be charged.

#### What is Fairness?

Every one has heard the words: It's not fair! But what does it mean to be that's what we're made of fair? What is fairness, after all? Here are three different ideas about fairness:

## Exhibiting CHARACTER during competition.

~ share time and use of limited resources such as wash rack space ~ follow guidelines and ethics for exhibiting and positioning animals in the show ring.

~ encourage fellow exhibitors at all times. Lend a hand to others. ~ make fair decisions by using the

follow show rules and regulations.


Quote of the month: "Many things in life are not fair, but all things should be."

~SAMENESS: There is the fairness where everything is equal. So everyone pays the same price for a theater ticket, whether a child, an adult or a senior citizen. No one has more than another.

~DESERVEDNESS: In this notion of fairness you get what you deserve. If you work hard, you succeed and keep all that you earn. Fairness means keeping what you deserve and deserving nothing if you have not earned it. The hardest working, most diligent have more because of their character; the lazy, indifferent have less. This is fairness as individual freedom.

~NEED: The third idea of fairness is that those who have more to give, should give a greater percentage of what they have to help others. Fairness here takes into account the facts that humans have obligations to one another. This is fairness as social justice.



#### Fairness Activity Corner?

#### Supplies:

Paper; pencils or pens

#### Directions:

Read the following scenario: A student is playing catcher in a softball game. Another student on the opposite team runs to home plate after his teammate hits the ball. As the runner slides into home plate, the catcher catches the ball and tags him. The runner says he is "safe." The catcher says he is "out." Fans sitting on one side agree with the runner. Those on the other side agree with the catcher. Who is correct?

Solicit answer.

#### Processing:

Explain: Either of the players might be correct because they saw the throw from different points of view. Then ask students to help define "point of view." How could each player act more fairly if he considered that everyone had a different point of view? Suggest: The players might have been more willing to accept the other's opinion. Or they could have decided to have the hitter bat again. Or simply accept the rules of the game and the umpire has the final say. Everyone has his or her own view of things. Sometimes things are clearly right or wrong, other times it is not so clear cut. Conclude by having the youth write the story from another person's point of view that would be at the game. Discuss their stories.

#### Calico Bean Salad

Makes 6 cups or 12 servings

#### Ingredients

- 2 cups navy, Great Northern, or small white beans cooked or a 1 15-ounce can, drained
- 2 cups chickpeas or garbanzo beans cooked or 1 15-ounce can, drained
- 1/2 cup low-fat Italian dressing
- Salt and black pepper to taste
- 2 tomatoes, cut into wedges
- 1 cup onion slices, separated into rings

#### **Directions**

- Washing hands with warm, soapy water for 20 seconds
- In a large bowl, mix together beans. Cover with dressing. Add salt and pepper and mix until beans are coated.
- 3. Refrigerate for 2—3 hours until completely chilled.
- 4. When ready to serve, mix again.
- Serve in a bowl and top with tomato wedges and onion rings.

#### **Deviled Eggs**

Makes 6 eggs or 6 servings

#### Ingredients

- 6 eggs
- 1/4 cup light mayonnaise
- 1 teaspoon prepared mustard or dash of dried mustard
- 1/8 teaspoon salt
- Dash of black pepper
- Dash of paprika

#### **Directions**

- 1. Wash hands with warm, soapy water for 20 seconds
- 2. Place a single layer of eggs in a sauce pan. Add enough cool water to rise at least 1 inch above eggs.
- 3. Over medium heat, bring water to just boiling. Cover pan and remove from heat.
- 4. Let eggs stand about 12-15 minutes.
- 5. Run cool water over eggs until cool enough to handle.
- 6. Peel eggs, then gently scoop egg yoks into a resealable plastic bag. Add mayonnaise, mustard, salt, and pepper. Seal the bag.
- 7. Mash or knead the bag to blend ingredients.
- 8. Push mixture toward one corner of the bag. Snip off the corner. Squeeze yolk mixture into white halves of eggs.
- 9. Sprinkle with paprika.
