Dear 4-H Families & Friends:

A role model is a person whose behavior is imitated by other people, and engages in positive and constructive actions. Additionally, those who have bad habits may lead such negative and destructive lives that they are examples of *what not to do.*

4-Her's who have positive, strong role models to follow have a better chance of developing and implementing positive choices in their own lives. While everyone may have a different definition of what a good role model is, here are some with which most people would agree.

- Youth look up to a person that is able to relate to him or her, share knowledge and experiences that they find relevant, as well as skills and personal characteristics such as being greeted with a smile and someone who knows and uses their name.
- Youth want to be in a place that feels safe and have the support of their club. They need to know those adults and fellow 4-Her's will treat them with respect as a valued member of the club.
- Youth want leaders who provide activities with purpose so that they may walk away with a skill and/or information that is of benefit to them.
- ♦ Youth look for and need independence to try things. They need the opportunity to problem solve as they learn. The adult is there to motivate and assist…not take over.
- Youth need many positive role models for guidance, encouragement, and opportunity.

Role models live their values in the world, and is *other-focused* as opposed to *self-focused*. As Booker T. Washington once said, "Success is to be measured not so much by the position that one has reached in life as by the obstacles which one has overcome." Young people admire and emulate those who guide them through pitfalls and obstacles and not only showed them but encouraged them that success is possible.





QUINCY'S CORNER







HOW TO SIGN UP FOR THE FIRST TIME IN ZSUITE



- Fill out the Register New Household Information. Select a Primary Profile Access PIN which is needed to
 enter the primary household account. Click LET'S GO (If you get an error message that your email
 address is already used, go back to the main screen and click on Forgot Password? as some profiles
 were transferred over from 4HOnline.com)
- 3. You are now on the Dashboard screen. Click + HOUSEHOLD MEMBER

 Enter the First Name, Last Name, Role (Member or Volunteer), and Member's Birthday. You may choose a preloaded avatar or upload a personal photo by clicking CHOOSE PICTURE. Click CONTINUE
- 4. Select the PERSONAL INFO tab. All fields marked with an asterisk (*) are required. Click NEXT to get to the WAIVERS tab.
- 5. Select the WAIVERS tab. Click ↓ next to each section to sign off on all the waivers. (You must agree in order to proceed.) On the Health Form, put N/A or none if the required field does not apply to your member. Click NEXT to get to the CLUBS tab.
- 6. Select the CLUBS tab. Choose your club from the drop down menu. Click ADD CLUB NATRONA COUNTY 4-H FIRST TIME MEMBERS: If this is your first year with the Natrona County 4-H, please choose "1-Club Placement Requested Natrona". The Natrona County 4-H Office will assist you in placing your member in a club that has openings based upon the projects that your child has enrolled in.
- 7. Select the PROJECT tab. Choose project from the drop down menu. Click ADD PROJECT. Repeat process until all projects are selected. Some Animal Projects have a required field that you may not have information for. If this happens, please enter this 4-digit number "0000" in that required field. CLOVERBUD MEMBERS: Choose only the Cloverbud project.
- 8. Verify all information is correct including your Club and Project selections. Click SUBMIT After you Click SUBMIT, your enrollment will be sent to the Natrona County 4-H Office Administrators for approval.



2021 QUALITY ASSURANCE

YOUTH PLANNING TO SELL AN ANIMAL THROUGH THE CENTRAL WYOMING FAIR JR. LIVESTOCK SALE MUST COMPLETE A QUALITY ASSURANCE TRAINING EACH YEAR.

The 4-H Quality Assurance (QA) Class teaches youth about the quality of meat and food products that come from livestock. Quality assurance for livestock producers means making a promise to the consumers from food production animals. Quality assurance is a pledge or promise to:

1. provide a food animal product preferred by consumers, and

2. provide a safe, wholesome food animal product. Food animals are those whose products (meat, milk, and eggs) have the potential to become part of the food chain.

The promise made is that products from livestock will be the highest possible quality and 4-H/FFA youth producers will do everything possible to make these products safe to eat and that our sale is of the highest quality.

REQUIREMENTS FOR SALE ELIGIBILITY

▶ All FFA (13 and younger), Junior and Intermediate 4-Her's will be required to take **one** QA clinic each year to sell an animal(s) in the Natrona County Jr. Livestock Sale at the Central Wyoming Fair.

▶FFA & Senior members (ages 14- 19) will be required to take one year of QA education to sell an animal(s) in the Natrona County Livestock Sale at the Central Wyoming Fair. If the first year of a livestock project is taken as a Senior, the QA clinic must be taken that same year.

The FFA advisor may sign-off for that member to verify that the Quality Assurance requirement has been met for that member to sell in the 2020 4-H/FFA Jr. Livestock Sale for 2020. **Signed form is due to the 4-H Office by June 15, 2021.**


