Niobrara County Fair General Rules and Regulations

General Information - All Divisions

1. For regulations and information pertaining to a particular division (4-H, FFA or Open Class) refer to that division.
2. The Niobrara County Fair Board in conference with its judges, reserves the right to interpret all rules and regulations and to rule on any matters or differences arising out of published rules, or in matters not covered in print.
3. Open Class exhibitors must be current residents, or live in Niobrara County at least two months out of the year, (or have Lusk, Lance Creek, Keeline, Lost Springs, Van Tassell, Manville, or Node addresses); or be an active member of a Niobrara County Homemakers Club or a current member of a Niobrara County 4-H Club/Rawhide FFA. Only Niobrara County 4-H members may enter in the 4-H Divisions, and only Rawhide FFA members may enter in the FFA Divisions.
4. Work must be done from County Fair 2025 to County Fair 2026.
5. Work cannot have been shown at a previous County Fair.
6. Work must be done by the exhibitor.
7. All 4-H and FFA members must be in good standing with their organizations to be eligible to participate in the County Fair.

Premiums - All Divisions

1. If the total premiums due in any division, or class, exceed the allocated amount, the Fair Board reserves the right to scale down the amount of premium paid to any exhibitor.
2. Exhibitors should cash their checks immediately.
3. 4-H and FFA Premiums will be withheld until the end of the project year in October. No premiums will be paid to 4-H and/or FFA members who do not complete their projects and record books (4-H only) or do not clean their livestock and/or horse stalls after the County Fair. If each of the members' Record Books does not receive at least a red ribbon, their premiums will be forfeited.

Judging Procedures - All Divisions

1. Every effort will be made to secure competent judges. Judge's decisions are final, and no appeals will be accepted.
2. Judging for all indoor exhibits begins promptly at 9:00 am on Friday. No late entries will be accepted.
3. Any exhibitor or representative of who interferes with the judge's performance or placings in any way or form; will cause the exhibitor's disqualification from competition and forfeiture of all premiums and ribbons awarded.
4. Any exhibit found to be tampered with, doctored, or entered in violation of rules applying to a particular lot or division will forfeit all premiums and ribbons awarded.
5. In case of no competition, or where insufficient entries are made to place them in order of merit, or where entry quality does not meet standards, the judge is not bound to award any particular ribbon type. No "automatic" Blue Ribbon will be awarded.
6. The judges will place all creditable exhibits in each class into groups according to excellence. These differ in each main division.

4-H and FFA Interview Judging Schedule

1. Interview judging for indoor project areas (except for Department A entries and 4-H Gardening/Horticulture) will be held on Wednesday, July 22nd starting at 9:00 am.
2. Interview judging for Department A entries and 4-H Gardening/Horticulture will be held on Monday, July 27th starting at 9:00 am.
3. All 4-H and FFA members are asked to be in the auditorium during their scheduled club interview time, starting at 9:00 am.

4-H and FFA Divisions

1. Danish System: Blue Ribbon Group (very good), Red Ribbon Group (good), White Ribbon Group (satisfactory).
2. In addition: Family & Consumer Sciences, General and Agriculture exhibits of Superior Merit will be awarded a Purple Ribbon. Exhibits judged as Champion and Reserve Champion are awarded appropriate ribbons.
3. There is no predetermined number of ribbon awards to be placed in any one ribbon group.
4. Ribbons are awarded according to individual merit.

Open Class Division

1. Exhibits entered in any one class or exhibit group will be placed according to individual merit within the group; American System:
2. 1st place - Blue Sticker, 2nd place - Red Sticker, 3rd place - White Sticker.
3. Only one Blue, Red, and White sticker can be awarded per class.
4. Champion and Reserve Champion ribbons will be awarded in cases where exhibit merit is warranted.
5. Stickers may be exchanged for corresponding colored ribbons at the Extension Office after the Fair if desired.
6. Open Class exhibitors are allowed multiple entries per class.

Exhibit Entry and Removal - All Divisions

1. All exhibits 4-H, FFA, and Open Class must be entered on the proper form. Entry forms are requested to be received at the extension office by July 17th. **Absolutely no Open Class entry forms will be accepted after 5:00 pm on Tuesday, July 21st.**
2. 4-H, FFA, and Open Class exhibitors will receive computer-printed entry tags upon arrival at the Fair. It is the exhibitor's responsibility to determine if the information on the tag is correct and attach it correctly to the exhibit. All entries must be completed, grown, or be of the current year's efforts to be eligible for competition.
3. Entries remain the property of the exhibitor, who is also responsible for entry and removal. Niobrara County Fair and its management are not responsible for the loss, theft, damage to, injury, or death of exhibits.
4. All entries displayed in the Exhibit Hall will be released at 9:00 am on Saturday and must be removed and the surrounding area cleaned by 10:00 am.
5. Junior Livestock exhibits will not be released until Friday after the Ag Olympics. Only the animal may go home. Tags and the rest of the exhibitors' belongings must remain on the grounds until clean up is finished on Saturday (except for cow-calf pairs, feeder calves, and horses - which are released after judging).
6. **The Fair Board reserves the right to withhold premiums on any exhibit removed before release time.**
7. **The Fair Board also reserves the right to withhold premiums when livestock pens and stalls are not properly cleaned and approved by a Fair Board member or the Superintendent.**

General Display Guidelines

1. Posters, pictures, artwork, and photography exhibits should come with a method for hanging them on hooks attached to a wire rack. If the items cannot be hung, they will be displayed on the floor or a table.
2. Display boards or poster boards must be able to stand "on their own" on a table.
3. Oversized exhibits will be displayed as space permits.

General Information Livestock and Agriculture - 4-H and FFA Divisions

1. The Fair Board will have a veterinarian on-site to do health inspections. See the schedule for times and dates.
2. **No animal (other than dogs) will be let on the Fairgrounds or stalled without the above-mentioned health inspection.**
3. **Stalling** - Livestock will be assigned pens or stalling areas by the Superintendent. All cattle will be secured with **both a halter and a necktie**. Official tie-outs will be available for all beef cattle. All cattle will be tied out at night and secured with both halter and neck ties. Cattle must be back in their stalls by 9:00 am each morning and must remain tied in the barn until 6:00 pm. **No grain allowed in beef stalls.**
4. **Showtimes** - Exhibitors must show at the scheduled time. Any animal inadvertently entered in the wrong class may be assigned correctly or disqualified at the show committee's discretion. Times will be posted in barn areas and will follow the order printed in the schedule unless circumstances dictate changes. Exhibitors will be given sufficient notice of show times.
5. **Ownership Deadlines:**
 - Market Cattle - February 1st
 - Horses - May 1st
 - Dog - May 1st
 - Breeding Cattle (including prospect feeder calves) - June 1st
 - All other junior livestock (sheep, swine, rabbits, goats, etc.) - June 1st
 - Proof of ownership by the ownership deadline must be provided to the Extension Office (i.e., Form A, bill of sale, or registration papers).
6. All market goats and lambs must still carry all of their milk teeth; normally, these animals are younger than one year of age.
7. **Showmanship** - Any animal is eligible within their respective species, with the exception of bulls, stallions, rams, billies, and boars. A member must show their own project animal in showmanship. Animals shown in showmanship must be shown in either a market or breeding class to be eligible.
8. Age classification for showmanship - Divisions are based on age as of January 1 of the current fair year. Junior (8-10 years), Intermediate (11-13 years), Senior (14-18 years).
9. **ONLY ANIMALS SHOWN AT THE NIOBRARA COUNTY FAIR CAN BE SHOWN AT THE STATE FAIR.**
10. Dress code for showing livestock:
 - Clothing should be neat, clean, and free of holes.
 - Long or short-sleeved button-up shirt (polos included) should be worn.
 - Long pants and appropriate footwear (no sandals, open-toed or tennis shoes) should be worn.
 - When showing Dairy animals, white attire should be worn.
 - FFA members should refer to the FFA dress code.
 - If you choose not to wear the suggested clothing, you may be placed lower in your class based on the judge's discretion. Judging preference will not be given to flashy dressing.
11. Judges will place the blue group exhibits in order of merit.

Herdsmanship

1. Animals must be in the barn from 9:00 am - 6:00 pm.
2. Pens and stalling areas must be cleaned and bedded by 9:00 am each morning. Arrangements must be made with other 4-H or FFA members to care for stalling areas if the exhibitor cannot be present. Failure to keep the display area clean and have stalls/pens orderly at all times may result in forfeiture of premiums and/or awards.
3. Show boxes and other gear must be placed in such a manner that traffic through the barns is not obstructed.
4. A selected committee will conduct an ongoing evaluation of each club during the Fair. Awards will be given to clubs showing excellence in their efforts.
5. Cattle must be tied out in the official tie-out area and secured with both halter and necktie. Cattle must be watered outside the barn, in order to prevent wet and slippery floors in the barn.

Livestock/Horse Fitting and Showing Rules

1. All participants in the Niobrara County Fair must be involved and interact in the daily care and preparation of their fair projects.
2. A 4-H or FFA member must take care of, groom, and fit their own animals at Fair. A 4-H or FFA member may be assisted by others enrolled in 4-H or FFA. Youth exhibitors are expected to clean their own stalls, alleyway, and tie-out area. Adults are not allowed to feed, clip, groom, or wash animals once livestock are on the Fairgrounds. However, in the interest of safety, an adult may assist members if an animal blows up, gets away from a member, or needs medical treatment.
3. Assistance is defined as a learning situation where the person doing the assisting is educating the youth member as to the technique of fitting and showing. This person is allowed only to show the Exhibitor the proper skill or technique/skill required. The exhibitor is expected to be present and to perform the majority of each technique/skill required.
4. Violations of this rule must be reported to a Fair Board member before the animal enters the show ring. First violation will result in a verbal warning. Second violation will result in the disqualification of the animal from the Niobrara County Fair.
5. Members must exhibit their own livestock. In the case of multiple entries, other 4-H/FFA members may assist in showing the livestock.
6. Yearling bulls must be shown with a bull lead nose ring.
7. No beef grooming chutes.

4-H Family Backup Animal

The 'Family Back-up Animal' is an opportunity for families to identify an animal as a 'backup' in the case of death, not making weight, or other unforeseen circumstances. Those livestock eligible for this opportunity include: Market Beef, Market Goat, Market Sheep, and Market Swine. These animals must be officially designated each year by the May Weigh-ins. Please refer to Page 28 of the 4-H Member Handbook for rules and further information, or contact the Extension Office.

Ultrasound Contest

1. An ultrasound contest will be held on Wednesday beginning at 4:00 p.m. for all 4-H and FFA Market Beef, Goat, Sheep, and Swine projects.
2. Animals MUST have made weight to be eligible for the Ultrasound Contest. Animals MUST have an initial weight on file to participate.
3. Dr. Steve Paisley, UW Extension Beef Specialist and Certified Ultrasound Technician will be collecting the ultrasound images and determining the winner of each of these contests
4. No pre-entry required.

Class

1. Beef Ultrasound Contest
2. Goat Ultrasound Contest
3. Sheep Ultrasound Contest
4. Swine Ultrasound Contest

Grievances/Protests

1. Shall be in writing accompanied by \$100.00 cash and given to the Fair Board Chairman. They must be filed on the day the infraction/complaint takes place. If allowed by the Fair Board, the fee is returned. If the grievance is not allowed, the money will be deposited into the fairgrounds improvement fund.
2. **Judges decisions are final and may not be protested.**

Niobrara County Fair Junior Livestock Sale Regulations

1. Each exhibitor may sell one beef, one lamb, one hog, one goat, one pen of rabbits, and one pen of poultry.
2. To be eligible for sale, an animal must meet minimum show weight for its type, have been shown in its respective class, and the member must attend at least one livestock judging and at least one Educational Opportunity (Ed. Op.) during the year.
3. Members must complete a consignment form for each species they intend to sell within thirty minutes of the end of the respective livestock show, and submit said form to a designated Fair Board representative.
4. If animals are not tagged and recorded at the Extension Office, they will not be sold at the Junior Livestock Sale.

1. Minimum Show and Sale Weights:

- a. Market Steers ----- 1150 lbs. min. - 1400 lbs. max.
- b. Market Heifers ----- 1050 lbs. min. - 1400 lbs. max.
- c. Lambs ----- 110 lbs. min. - 150 lbs. max.
- d. Hogs ----- 220 lbs. min. - 285 lbs. max.
- e. Market Goats ----- 50 lbs. min.
- f. Market Rabbits ----- 5 lbs.
- g. Turkeys ----- 20 lbs. min. - 37 lbs. max.
- h. Geese ----- 8 lbs. min. - 22 lbs. max.
- i. Ducks ----- 5 lbs. min. - 16 lbs max.
- j. Chickens ----- 5 lbs. min. - 10 lbs max.

1. Animals not meeting the minimum weight will not be eligible for the Junior Livestock Sale. Animals will be shown in a special feeder class. Animals weighing more than the maximum weight will be allowed to sell in the Junior Livestock Sale. However, any poundage over the maximum weight will be given to the buyer for free. There is no maximum on the show weight. Maximum weight pertains to pay weight only. Animals exceeding the maximum weight are still eligible for Grand/Reserve Champion selection.

2. **There will be no re-weighing of animals.**

3. Two individuals appointed by the Fair Board will weigh and record fair weights. No one else is allowed in the weigh-house during the weighing of animals.
4. All animals must be shown in a market class in order to be allowed to sell.
5. All Champion and Reserve Market animals must sell. Should one member own both the Grand and Reserve Champion animals of one species, the member does not get to choose which animal to sell. The member must sell the Grand Champion animal of that species.
6. The Sale Committee reserves the right to weigh animals on the day of delivery. The animal must have maintained or gained weight since the County Fair.
7. The Sale Committee will do everything in its power to have bills sent no later than September 1st and payment sent to you as soon as possible. However, please note that you will not receive payment until the Extension Office has received your W-9 form and thank you note (stamped and addressed). **Do not** send them directly to the buyer; we must see them first. Furthermore, you will not receive payment until your buyer has paid.
8. Sale Checks will be mailed to the address you provide on your consignment form.
9. All poultry must be delivered to the buyer within two weeks of the Market Animal Sale.
10. Sale commission will be 3% on sale price and any add-on funds received.

Agriculture Department A

All exhibits must have been grown in Niobrara County and a product of the current year except corn, threshed grain, and threshed forage seed, which may have been a product of the preceding year.

5. **FOOD SAFETY:** Exhibits are on display for several days. Please think about **FOOD SAFETY!** Items that require refrigeration will not be accepted, judged, or displayed as exhibits must be safe to eat when entered, whether they are tasted or not. Glazes, frostings, and other sugar-based toppings are considered safe due to their high sugar content. Egg glazes on yeast breads and pie crusts **BEFORE** baking are acceptable. Eggs incorporated into baked goods and crusts are considered safe. The following food ingredients are considered unsafe for fair exhibits and will be disqualified:
 - a. Egg or cream fillings and cream cheese frostings
 - b. Any meat item including meat jerky, imitation meat bits (bacon bits, pepperoni, etc.)
 - c. Melted cheese on top of food exhibit (cheese mixed into baked goods is considered safe and will be accepted)
 - d. Uncooked fruit toppings (i.e., fresh fruit tart).
6. Smaller baked items (rolls, cookies, biscuits, muffins, scones etc.) place 3 items for each entrée.
7. Large baked items (cakes, loaves etc.) enter $\frac{1}{4}$ of the item. Breads will be displayed as an end-cut, cut from top crust to bottom.

3. Current USDA processing methods and altitude adjustments must be followed for all food preservation. Jam, preserves, and marmalades, fruit, tomato, and pickled products must be processed in a boiling water bath. Tomatoes may be processed in a pressure canner. All non-acid vegetables and meats must be processed in a pressure canner. Improperly canned or potentially hazardous food items will be disqualified. A spoiled or unsealed container disqualifies entry.
4. Standard canning jars (half-pint, pint, quart) must be used for all canned exhibits. (The brand name, such as Ball or Kerr, imprinted on the side of the jar, identifies a standard jar.) All jars must have two-piece metal canning lids (flat and band). Reusable lids and one-piece lids are not allowed. Decorative storage containers that have a rubber seal are not acceptable for canning exhibits.
5. All canned goods will be exhibited without rings. Transport canned goods with rings on, remove them at the fair, and keep the rings with you. Rings must be removed for judging.
6. Preserved foods may be opened at the fair for tasting by the judge. If jars are opened, the exhibitor will be notified and the entrée will be placed in a refrigerator.

Niobrara County Born and Raised Market Contest

The purpose of the Born and Raised Market Contest is to recognize quality Niobrara County born and raised market animals shown at the Niobrara County Fair.

1. This contest is open to all eligible Niobrara County 4-H and Rawhide FFA members.
2. Animals must fall under one of the following options:
 - a. Be born and raised by a Niobrara County Producer and purchased by a Niobrara County 4-H member or Rawhide FFA member.
 - b. Be born and raised by a Niobrara County 4-H member or Rawhide FFA member. *Considerations may be made for those 4-H/FFA members not residing within the boundaries of Niobrara County by consultation with the 4-H Educator or FFA Advisor and the Niobrara County Fair Board.
3. Members must designate animals intended for this contest at County weighing and tagging and turn in the Contest Agreement.
4. Purchased and/or contestant-raised animals must be fed by the contestant from the time of 4-H/FFA Ownership Deadlines.
5. Members wanting to participate in this contest must sign up for the class through the fair entry system and must be completed when fair entries are due.

6. The Niobrara Born and Raised Contest is available to Beef, Goat, Swine, Sheep, and Poultry.

7. Animals must make the minimum weight according to the Niobrara County Fair Market Show rules, meet all other Niobrara County Fair entry criteria, and must compete in the regular Niobrara County Fair market class.

8. This is a Niobrara County contest only, winning this class does not make the contestant eligible for any State Fair contests.

9. The Niobrara Born and Raised contest will follow the Market Show.

10. Placings will be given to Grand and Reserve.

11. If it is found that the member has been deceitful in any part of the contestant agreement concerning the animal's origins, the member is no longer eligible for future Niobrara County Born and Raised Contests.

4. All dairy goats will stay in the barn on the fairgrounds. No dairy bucks allowed to show or stall on the grounds unless nursing from the doe. They must stay in the same pen with the doe and siblings and must be 3 months or younger at the time of the county fair.
5. All dairy goats must be clipped to the breed standard or shorter. Fitting of dairy goats will be left to the discretion of the exhibitor, but animals are to be shown in natural conformation and color.
6. Upon entry, the breeding animal's birthdate and ear tag or identification number/tattoo (which is permanently attached to the animal) must be used. Each animal must have a unique identifier that will be used when checking in for shows.
7. All dairy must be milked out by the specified time set by the superintendent. If the animals are milked out before the deadline, you must notify the superintendent for verification.

7. Animals must be checked in with a scannable RFID tag at the spring weigh-in or receive a WSF scannable tag.
8. Market goats must weigh a minimum of 50 pounds to sell, with no set upper weight limit.
9. No weigh-backs allowed. Weight grievances must follow grievance policies. Animals can not leave the scale area or supervision of fair officials weighing animals if a reweigh has been called.
10. The superintendent reserves the right to modify shows or make determinations at any time. The superintendent can make stall changes at any time. Any disputes will be settled by the superintendent in the applicable area as a representative of the fair board.
11. Halters with chains as leads must be removed for weigh-ins. Goats must have blankets or covers removed before coming to the scale.
12. Does entered and processed as breeding animals may not be exhibited as market animals. Does entered, processed, and shown as market animals may not be exhibited as breeding animals. WSF market tags must be removed from all breeding does prior to county fair.

Division 7-8**

1. The Niobrara County Junior Horse show will utilize the American Quarter Horse Association rulebook to determine appropriate courses of action for all performance and showmanship classes. Barrel racing, pole bending, goat tying, team roping, breakaway and other speed events will use the National High School Rodeo Association Rules. The judges interpretation of any rule is final.
2. For questions not covered by these rules, nor addressed in this premium book, the superintendents have the authority to settle disputes.
3. No lame horses, at the discretion of show management, will be allowed to compete. Disqualification resulting from this rule is final.
4. No animal that is determined by show management to be a danger to another horse or human will be allowed to participate for allowed to be on the grounds during these events.
5. You must have submitted a safety certification sheet by 4-H and FFA deadlines. An animal may be identified in only one organization. You must show the horse you have certified in FFA as an FFA entry or 4-H as a 4-H entry. You may not show the same horse in both 4-H and FFA.
6. Horse identification rules regulating eligibility to enter at the fair will be managed by the respective organization the exhibitor is showing.
7. Each club member may own, lease or possess as many horses as he or she desires. However, each horse can only be exhibited by a single member.
8. In extreme circumstances, such as the death of a horse, the Fair Board and 4-H/FFA Educator may determine a youth exhibitor can safety certify with/or exhibit a leased horse after the safety certification deadline but before the county fair.
9. No stallions of any age or mares with colts at side are allowed.
10. Classes are run in book order. We will begin promptly at 8AM. No classes will be held for you. Be on time.
11. All horses must be at a walk and under control outside of the arena.
12. 4-H Champion Junior, Intermediate, and Senior Showmanship winners and the Champion and Reserve Champion FFA showman will compete in Round Robin on the last Friday of fair.
13. Stalls must be cleaned and signed off by superintendent by the end of the fair week.
14. Speed Event Rules: Speed events will be judged by time only. There is a 5 second penalty for each barrel or pole knocked.
15. The Niobrara County Fair Board, 4-H Council, and Extension Office prohibit individuals from riding horses bareback, riding double, riding without bridles and reins, or riding backward. Horses are to be kept in the horse stall and arena areas. Horses are not to be led or ridden through the other livestock barn area, around the exhibit hall or concession building, on the sidewalks, or on the lawn. Horses should be ridden and/or kept in the horse barn or to the south and east of the horse arena.

7. Halters with chains as leads and blankets/all coverings will be removed for weigh-ins.
8. Animals must be checked-in with a scannable RFID tag at spring weigh in or receive a WSF scannable tag.
9. The slapping or lifting of market lambs in the show ring is not allowed. All lambs must have four feet on the ground during the judge's inspection or handling. Lifting the feet off the ground or placing feet on any support or altered ring surface is not acceptable. Exhibitors will receive one warning if they are found lifting or slapping lambs. Second offenses will result in automatic exhibitor and animal disqualification.
10. Ewe lambs entered and processed as breeding animals may not be exhibited as market animals. Ewe lambs entered, processed and shown as market animals, may not be exhibited as breeding animals. WSF market tags must be removed from all breeding ewe lambs shown at county and state fair.
11. The superintendent reserves the right to modify shows or make determinations on rules at any time. The superintendent can make stall changes at any time. Any disputes will be settled by the Superintendent in the applicable area as a representative of the fair board.
12. There will be no muzzles, of any type, allowed on youth livestock unless approved in writing by a licensed Wyoming veterinarian and presented to the specific superintendent prior to weighing in their animal. Drenching as a method to source nutrition and hydration is allowed. **Drench can be administered ONLY by the 4-H/FFA member who owns the animal. Drenching is only allowed in the barns.**

13. Breed Classifications:

- a. Blackface Market Lamb
 - Black face: These are generally white, or natural colored bodied, black or a black and white wool/hair mix on their legs, with a black head. Some blackfaces may have a Hampshire appearance with a wool/light colored faceplate.
- b. Whiteface Market Lamb
 - Whiteface: Lambs that are crossed with a wool type or Dorset. They have white heads, bodies, legs and generally have white hooves. No black marking of any kind is allowed in the whiteface division.
- c. Speckled face Market Lamb
 - Speckled face: These are generally a cross between a wool breed and a blackface (meat) breed. Lambs should show significant evidence of their wool breed ancestry. Skin will appear pink, white wool, brown/black spots in conjunction with wool in legs below the knees/hocks, significant brown/black spots on the face plate. Being wool crossbreds, may also have a smut face (light brown mottling on the face and legs).

2. Each pen may have one additional handler to set up and exhibit the pen. All exhibitors and handlers must be 4-H/FFA members within their respective club/chapter.
3. Pens will be evaluated on appearance, uniformity, and market quality.

Junior Breeding Sheep Show Division 10

1. ALL breeding sheep must have a USDA/APHIS Scrapie tag.
2. ALL breeding sheep must be shorn or hand sheared to breed standard. Fitting of breeding sheep will be left to the discretion of the exhibitor, but the animals are to be shown in natural conformation, color and breed standard. All sheep must be shorn after January 1 of the current year.
3. When entering breeding animals a birthdate and ear tag or identification number/tattoo (which is permanently attached to the animal) must be used. Each animal must have a unique identifier that will be used when checking in for shows and classification.
4. Ewe lambs entered and processed as breeding animals may not be exhibited as market animals. Ewe lambs entered, processed, and shown as market animals, may not be exhibited as breeding animals. WSF market tags must be removed from all breeding ewe lambs prior to county fair.
5. Animals shown in the breeding classes must be ewes or rams. No castrated males allowed.
6. Yearlings entered in the yearling classes MUST have yearling teeth and must be born in the previous year.
7. All sheep shown in Flock Class must have been shown in their respective classes at the current years Niobrara County Fair.
8. The superintendent reserves the right to modify shows or make determinations on rules at any time. The superintendent can make stall changes at any time. Any disputes will be settled by the Superintendent in the applicable area as a representative of the fair board.

1. Entries will be judged on the basis of workmanship, evidence of sound planning, number and degree of skills involved, practicality and agricultural usefulness of entry.
2. All entries must be student's work and result from the training program in agricultural mechanics.
3. The judges reserve the right to re-enter entries in classes in order to make more judgable groups of entries.
4. Judges shall give greater consideration to an item built entirely by the student rather than a pre-fabricated item.
5. Entries in class 1 must be mounted on a display board that may be any size less than 2ft by 4 ft. Display boards may represent several students' work. Points from these classes will have equal value with other similar classes in judging sweepstakes. Individual items not mounted will not be judged. Boards not meeting the specifications will be placed lower than those boards that do.
6. All entries must be removed from equipment and placed in the proper class area to be judged. Example: pickup bumpers and stock racks.
7. All projects not of quality will not be judged. This will be left to the discretion of the agriculture mechanics committee. The item must be removed from the display area.
8. Any entries in the agriculture mechanics class that are found to have been shown in a previous year will disqualify that chapter, for all premiums, for the current year, in the agriculture mechanics show. The agriculture mechanics committee shall have the responsibility for making this decision.

4-H Dog Show Division 15

General Information

1. Rules in the current Wyoming State Fair Premium book and the 4-H project manual will serve as the official rules for the obedience and showmanship contests. You are responsible for knowing and complying with those rules.
2. "A" Classes are for dogs that have not had a qualifying Obedience or Rally score in AKC Competitions or do not have an Obedience or Rally Title in AKC Competitions. "B" classes are for dogs that have had a qualifying Obedience or Rally score in AKC competitions or that do have an obedience or Rally Title in AKC Competitions.
3. To enter agility, you must have entered obedience or showmanship.

4. Dogs must have current immunizations including: Rabies, Distemper, Parvo, Parainfluenza, Adenovirus and Bordetella.
5. Rabies vaccinations must be renewed under state guidelines. Dogs must be accompanied by an official health certificate by a veterinarian to participate at Niobrara County Fair.
7. Dogs must be on leash at all times and are confined to the area of the dog show and staging area. Do not enter the activities building or livestock barns.
8. Dogs are released following the show.
9. Showmanship classes will be grouped by age group.

Obedience and Showmanship Rules

1. A 4-H member may compete in only one obedience class per dog. If there is more than 1 dog, then each dog shall be referred to as "A" and thereafter for class entries.
2. The first year beginner novice class is for members who are in their first year of the dog project, not the first year with a new dog. It is designed as a training class for members who do not feel competent to start in On Leash classes. Members may compete in the first year beginner novice class only once.
3. A 4-H Exhibitor with a dog shown previously in obedience classes by another 4-H member, or a dog that has a title from another organization or has three qualifying scores from the designated annual county 4-H show, must show the dog by these guidelines:
 - a. Junior and Intermediate age exhibitors may move back or down one level.
 - b. Senior age exhibitors must show the dog at the highest level the dog has achieved.
4. A dog receiving a qualifying score of at least 170 points at the designated annual county 4-H show may advance after receiving 3 qualifying scores from the designated annual 4-H show. Once the higher level of obedience is selected for the dog, the member may not drop back/down to the lower level with the same dog.

4-H Dog Obedience

Competition Guidelines

1. All dogs must enter/leave the show ring and compete with a leash, dependent on class rules.
2. Bait and/or toys are not allowed in obedience competition.
3. Dogs soiling or urinating in the ring during judging will be disqualified and receive no score.
4. Males and females will be shown in the same class. Females in heat will be shown last in the class and must be kept away from the obedience ring until call time.
5. An identification paper must have been filed with the extension office by May 1st.

Competition Guidelines Cont.

6. Governing rules shall be from the Wyoming State 4-H Dog Show Guidelines, not AKC Guidelines. Classes will run in book order unless exhibitors are notified prior to the show.

7. 4-H members in the dog project may use co-owned or leased dogs. The member must have responsibility for the sole care, training, and showing of that dog for the current 4-H year, and in the case of a co-owned dog, there must be a training contract.

8. Dogs may only be taken into the Livestock Show Arena or Swine Barn for Staging.

9. Be prepared to clean up after your dog while on the fairgrounds.

10. Vicious dogs will be dismissed from the ring and must be immediately removed from the fairgrounds.

11. An exhibitor must show with a six-foot (6') leash unless otherwise determined by event regulations.

12. The Wyoming 4-H Dog score sheets were designed for the benefit of 4-H members. They are intended as guides for judges. Judges use their discretion in deciding the seriousness of errors.

4-H Dog Conformation

1. Classes will be subdivided by breed within a class, if number warrant. First place winners will compete for Best in Show.

2. Exhibitors entering more than one dog in any class may be assisted only by another 4-H member, if the dogs must be shown at the same time.

3. Classes 12-19 will be judged according to AKC Standards, but it is not necessary that dogs be registered. They must be purebred; both mother and father of same breed.

4. Classes 20 & 21 will be judged according to the predominant breed characteristics and/or soundness, gait, condition and grooming.

5. Before entering your dog, check the list of breeds that are eligible for each group. It can be found online at <http://www.Wyoming4-H.org> under the dog project.

4-H Dog Agility

1. Agility classes are open only to members enrolled in the dog project in Niobrara County. Entry in agility is required to accompany participation in one additional area of the dog project.

2. Before competing in agility the team of dog and handler must have received instruction in agility procedures. It is mandatory that the team participate in one year of obedience concurrent or prior to instruction in agility.

3. Dogs must be one year of age by May 1st.

4. Obstacle contact familiarization for handler and dogs on levels 1, 2, and 3 will be held before competing. A separate course of familiarization for handler only will be held, not to exceed 10 minutes for each level.

5. Bait may not be used in competition.

6. Dogs in heat will run at the end of the class. We discourage competing with very pregnant dogs.

7. You must use a flat, buckle collar with nothing hanging from it. Leashes, if allowed, can be up to six feet in length.

8. State entrants must achieve qualifying scores at their county level before competing in the state 4-H dog show. The level at which a member qualifies at the county is the level in which they will compete at the State 4-H Dog Show.

9. A dog receiving a qualifying score of at least 75 points at the county 4-H Show may advance the following year to the next higher class but must advance after receiving 3 qualified scores from the designated county show. Once the higher level in agility is selected for the dog, the member may not drop back to the lower level with the same dog.

10. Youth, with a dog shown in previous years by a different member, or a dog that has a standard agility title from another organization or has received 3 qualifying scores from the designated annual county 4-H show must show the dog under those guidelines.

11. Junior and Intermediate aged 4-H youth may move back/down one level.

12. Senior aged 4-H youth must show the dog at the highest level the dog has qualified.

13. All dogs must enter and leave the ring on leash.

14. Level 1 dogs will run on leash. Level 2 dogs must run off leash or with a tab no longer than 6". Collars must be flat, buckle variety with nothing hanging from it such as tags.

15. A time for all handlers to familiarize themselves with the course they are competing in will be established and announced.

16. To qualify for agility competition, the handler must compete in obedience or showmanship classes at fair.

17. Same day advancement to another level is not allowed. However, Junior and Intermediate members with a dog shown previously by another member of AKC agility show champion may move back/down one level. A senior member with the same dog, must show at the last level in which the dog competed.

- Level 1: Six obstacles. Dog walk, single bar jump, wall jump, broad jump, open tunnel, pause table. On or off leash, no penalty for touching dog or obstacles, Qualifying score is 150; time allowed: 1:30.
- Level 2: Nine obstacles. All six from level 1 plus A Frame, tire jump, and closed tunnel. Qualifying score is 150; time allowed: 2:00
- Level 3: All of level 1 & 2 obstacles plus double bar and/or seesaw. Off leash, collar optional. Qualifying score is 175; time allowed: 2:00.

5. Food Safety: Exhibits are on display for several days. Please

think about FOOD SAFETY! Items that require refrigeration

will not be accepted, judged, or displayed as exhibits must be safe to eat when entered, whether they are tasted or not. Glazes, frostings, and other sugar-based toppings are considered safe due to their high sugar content. Egg

glazes

on yeast breads and pie crusts BEFORE baking are acceptable. Eggs incorporated into baked goods and crusts

are considered safe. The following food ingredients are considered unsafe for fair exhibits and will be disqualified:

- Egg or cream fillings and cream cheese frostings
- Any meat item including meat jerky, imitation meat bits (bacon bits, pepperoni, etc.)
- Melted cheese on top of food exhibit (cheese mixed into baked goods is considered safe and will be accepted)
- Uncooked fruit toppings (i.e., fresh fruit tart).

6. Smaller baked items (rolls, cookies, biscuits, muffins, scones etc.) place 3 items for each entree.

7. Large baked items (cakes, loaves etc.) enter ¼ of the item. Breads will be displayed as an end-cut, cut from the top

crust

to the bottom.

Spoiled or unsealed container disqualifies entry.

(The brand name, such as Ball or Kerr, imprinted on the side of the jar identifies a standard jar) All jars must have two piece metal canning lids (flat and band) Re-usable lids and one piece lids are not allowed.
